Ninja Youth Foundation, presented by Dean Kobashigawa, accepting the award was Robert Nakamae, President: From its beginnings in 1980 the Ninja Youth Foundation greatly increased the opportunities for Asian American youth to participate in competitive, tournament basketball in the San Jose area.

Chris Tsuji, presented by Mark Kobayashi: The recently retired high school mathematics teacher spent over 35 years nurturing the math contest which started in 1969 as the San Jose – Okayama Sister City Friendship Exchange Mathematics Contest and concluded a 43-year run last year under its most recent name, the San Jose JACL – Tokutomi Mathematics Contest in honor of the founders, Kiyoshi and Kiyoko Tokutomi.

Sharon Uyeda, presented by Shirley Ota: Sharon started as a Jr. JACLer and co-chaired the 1968 National Youth Convention, which was held concurrently with the San Jose JACL hosted National Convention. When SJ JACL again hosted the JACL National Convention in 1996, Sharon chaired the program booklet committee and the fashion show. With her background in education, Sharon has been involved with the SJ JACL scholarship program for over 35 years, serving apprenticeship under Helen Mineta and continuing on as chair of the scholarship committee. She has co-chaired recent fund raising dinners and continues to serve both on the Chapter Board and on the JACL District Board.

Joe Yasutake, presented by Dr. Jerrold Hiura: Since his well-earned retirement in 1994, Joe has been toiling almost full-time in the community. He has been Chair of the Council of Ministries at Wesley United Methodist Church. For the Japantown Community Congress of San Jose (JCCsj) Joe was the first President and then later headed the Landmarks Committee which spearheaded the development of many of the historical landmarks seen throughout Japantown. Joe also has served as President of the Japanese American Museum of San Jose (JAMsj) where he continues to serve on the Board and to lead many projects.

Yu-Ai Kai, presented by Board President, Ben Katai, and accepting the award was Sophie Horiuchi-Forrester, Executive Director: Yu-Ai Kai (YAK) had its humble beginnings in the early 70's when a group of Sansei students from San Jose State University formed Asians for Community Action (ACA). Originally housed at what is now known as the Issei Memorial Building, ACA used volunteers to provide bilingual and bicultural services for local Japanese and Japanese American seniors, including social activities, traditional Japanese celebrations, art and crafts, and trips. In 1974 Yu-Ai Kai Japanese American Community Senior Service of San Jose officially came into being. Today YAK has two buildings of its own, paid staff and serves over 3000 seniors annually.



CATS Honors Dr. Jerry Hiura at September 7th Dinner Program by Tom Oshidari



CATS (Contemporary Asian Theater Scene) celebrated its 17th year with a dinner held at the Fairmont Summit Center with the primary purpose of "toasting and roasting" **Dr. Jerry Hiura**. Preceding the formal program was a cocktail hour and silent auction.

CATS officers Leianne Lamb and Caroline Moore acted as Co-MCs to introduce an extensive array of guests to sing the praises of Dr. Jerry. Steve Yamaguma started things off by speaking to the early years, surprising many with his portrayal of the young Jerry as an Afro-coiffed, headband-wearing musician. Young author and film maker, Tim Yamamura, whom Dr. Jerry has mentored (and whom, if I recall correctly, I coached in CYS basketball some 30 years ago), read original poetry published by Dr. Jerry many years ago. Throughout the evening, though, the message was clear that Dr. Jerry was a man dedicated to the arts and has contributed greatly to the cause. In fact he is one of the few to have achieved the "triple crown," i.e., holding the office of Chair of the City of San Jose Arts Commission, Vice Chair of the Regional Arts Council, and also being appointed Vice Chair of the State Arts Council by Governor Gray Davis.

Entertainment included ukulele music by Rodney Takahashi, taiko drums by Roy and PJ Hirabayashi (along with Dr. Jerry), piano and comedic banter by Jon Jang (again joined by Dr. Jerry), and jazz vocal stylings by Moy Eng.

A message from Prof. Evelyn Nakano Glenn, UC Berkeley

I am trying to locate Japanese American men and women who left California, Washington, or Oregon in response to the threat of internment and who lived in other states during World War II

During World War II, approximately 5,000 men, women and children "voluntarily" relocated away from the barred zone during the brief period between the announcement of the planned evacuation and the actual evacuation and incarceration. The experiences of these Japanese Americans have never been examined by historians or social scientists and my research will fill this void in Japanese American history by collecting oral history interviews of those who "self evacuated" so as to avoid forced interment. The study will address issues such as the difficulty of living outside of camp during a period of intense anti-Japanese prejudice, and the challenge of maintaining ties with relatives and friends inside the camps.

Elaine Reiko Akagi – the Passing of a Legendary JACLer

Elaine was a driven individual who was dedicated to the JACL organization. She chaired the July 2012 National JACL Convention in Bellevue, Washington during which she was named JACLer of the Biennium and prior to the Washington, D.C. Gala in October, it was announced that she would receive the prestigious JACL Ruby Pin. She served as President of the Detroit and Seattle Chapters, Pacific Northwest District Governor, and elected National Vice President for General Operations at the 2012 National Convention.

But as life would have it, at the height of Elaine's illustrious career, she was diagnosed with pancreatic cancer at the end of July and passed away on October 19, 2012.

San Jose Chapter Board member, **Sharon Uyeda** was a close friend for 45 years and recalls many JACL events that they attended together. Sharon flew to Seattle to attend Elaine's huge Celebration of Life held on December 8, 2012. **David Lin**, JACL

National President, and **Priscilla Ouchida**, JACL Executive Director, were both in attendance and each spoke her praises. A well deserved surprise was announced by Seattle Mayor **Michael McGinn** who after speaking about Elaine, read a proclamation designating an annual December 8th Elaine Akagi Day in Seattle and the hall burst into applause.

Memories of dedicated JACLers should not be forgotten. It is good to see that Seattle and others will forever recognize and keep Elaine in their hearts.

Cherry Tree Planting Ceremony Held at the Issei Memorial Building by Tom Oshidari

On September 15, 2012, the Issei Memorial Building (IMB) hosted a brief ceremony acknowledging the planting of a young cherry tree previously given to San Jose JACL by the Consul General of Japan in San Francisco and planted in the IMB front yard by **Tom Oshidari** and **Jeff Sera**.

100 years ago, the people of Japan gave 3000 cherry blossom trees, a beloved symbol of Japan, to the United States as a gesture of goodwill. The trees were planted in Washington DC's Tidal Basin, where they still blossom today, as part of First Lady Nellie Taft's efforts to beautify the nation's capital. Together with the Statue of Liberty, the cherry blossom trees represent the largest foreign gifts ever made to the United States.

As part of the centennial commemoration of this gift, Japan is once again donating cherry blossom trees to locations with significance to the friendship between the US and Japan. The IMB cherry tree is one such tree.

Tom Oshidari acted as Master of Ceremonies for a program where the following spoke briefly in turn: Reverend Keith Inouye, Wesley United Methodist Church of San Jose; Consul General of Japan, Hiroshi Inomata; Leon Kimura, San Jose JACL President; Sam Liccardo, San Jose City Councilperson, District 3 (includes Japantown); and Roy Hirabayashi, President, Japantown Community Congress of San Jose.

The hoped-for, long-lived symbol already has been sorely tested when someone knocked down the tree, cracking it at its base. However, the cambium layer was not severed; so Roy Hirabayashi applied his tender care and propped up the tree, hopefully to see it survive the dormant season and come back strong next spring.


Allegiance - The Controversy by Leon Kimura

The Sing Out Louise production company has come out with a new play entitled "Allegiance - A New American Musical" that opened at the Old Globe Theatre in San Diego. It boasts such stars as **Lea Salonga**, **Telly Leung** and **George Takei** and is a fictional story based upon the wartime perspective of one family, the Kimura's (no relation;), as they endured the tribulations of the time. The story is fictional except for one character, **Mike Masaoka**, the National Secretary of the JACL during WWII. Therein lies the seeds of the controversy.

Back in July 2010, when the play's "backers screening" came to the San Jose Stage and as the actors performed their "readings" of the raw script, on stage, all lined up in a row, seated behind their music stands, the character of JACL's **Mike Masaoka** was the only actor in "costume", wearing a flamboyant zoot suit and exuding a "shyster, slick-Willie" attitude while he helped perform all the "dirty work" for the WRA rounding up the JAs into the camps and then the army. And our jaws dropped as the cast launched into the song "A Jap is a Jap" (title taken from the infamous **General DeWitt** statement, and now removed from the play). Needless to say, the JACLers in the audience were outraged and a continuing dialogue between the producers and the JACL ensued.

Now over two-years later, and after many revisions to the play, the musical received mixed reviews but drew standing ovations. I did not see the final production but I understand that the portrayal of Mike is toned down (but still edgy from a JACL perspective including the disturbing message about the role played by our beloved veterans - expendable suicide squad). Artistic license was taken freely in some of the material resulting in misleading inaccuracies. But despite that, in my humble opinion, the real value to the play's success is the opportunity it creates to expose the mainstream of America (and the world) to the story of hysteria, prejudice and ignorance that enabled very bad decisions including unconstitutional actions to be taken incarcerating 120,000 Japanese, German and Italian Americans without due process of law. It opens the doors to further educational discussions and even to our own personal introspections.

You can be sure that with your continued support, the JACL will endure to help prevent the wartime tragedies and failures of leadership from happening again. CAIR - Upholding Our Constitution by Leon Kimura

In our continuing effort to support fellow civil liberties advocacy organizations, Board members **Tom Oshidari**, **Joyce Oyama**, **Neil Kozuma** and I attended the Council on American-Islamic Relations, San Francisco Bay Area Chapter 18th annual banquet. Always an entertaining, inspirational and educational event, this year's program was exceptional!

One speaker in particular resonated with me while addressing the topic: Upholding Our Constitution. Glenn Greenwald spoke of how the 911 event is eroding our civil liberties. He contends that we are engaged in a war on terrorism that is global and continuous and it is causing a fundamental transformation in our government where civil liberties abridgements become institutionalized. It has created a climate where extremist actions become normalized, such as the enactment of the USA Patriot Act with widespread reduction of intelligence-gathering restrictions. Or how about the signing of the NDAA in spite of the protests over the language that allows the

incarceration of Americans without due process?

The insidious part of all this change is the manner in which we, the American public, are becoming desensitized to the change. The war being waged has no end and we, including our youth, are slowly being trained to accept these abridgements to our civil liberties. There is a climate of fear occurring, both about terrorism and about retaliation if people protest the government actions (such as with WikiLeaks). Please do not unthinkingly accept these changes and make sure your family understands the freedoms to which they are entitled. Cherish the hard fought liberties provided to all Americans by the Issei and Nisei generations.

Thank you CAIR for continuing the good fight and helping to shine light in places where shadows would prefer to linger.

Why Planned Giving? by Steve Okamoto

Many donors assume the only way to make a gift to JACL is through an outright gift or a transfer of an asset like cash or real estate. While JACL certainly welcomes and encourages such gifts, it is also important for JACL supporters to know that other methods are available for supporting JACL's efforts- methods that help them achieve strategic goals for their families as well.

This method of giving is called "Planned Giving". At the heart of planned giving is the Internal Revenue Code, which encourages gifts to JACL by providing for significant tax deductions and savings. This is the government's financial reward for your generous philanthropy.

JACL supporters may not realize they may continue to receive income from assets that have been transferred. But through planned giving, it is possible to make a tax-deductible gift to JACL while retaining the right to use the asset or to derive income from it.

Through planned giving you could:

Minimize taxes from IRA or other pension plans-if retirement is subject to estate and income taxes.

Exchange highly appreciated assets for a lifetime income stream plus a tax deduction by using a charitable trust.

Following is a sampling of some of the most popular planned giving instruments available.

Wills/Bequests/Living Trusts

These are an effective way to provide for a loved one's financial security and to ensure that the donor's assets are distributed as desired after the donor's death. A bequest in a will or a trust beneficiary designation is especially appropriate for someone unable to make an immediate gift but would like to support the many activities and programs of JACL.

Outright Gifts

Gifts of cash, securities, real estate, insurance and personal property provide an immediate tax deduction of up to 50% of the donor's adjusted gross income with a five-year carryover.

Charitable Trusts

Charitable trusts are trusts established when a donor's assets are transferred to a trustee for the benefit of JACL. The donor would receive income for as long as he/she lives or for a fixed term. Donor is eligible for substantial tax benefits. Donor eliminates capital-gains tax on any appreciation. At the donor's death the remainder of trust is transferred to JACL.

JACL, using the experience of veteran planned giving expert **Steve Okamoto**, would work closely with you, your family members or your financial and legal advisers, to provide helpful information to determine how various planned giving instruments or techniques would work best for each individual.

The final portion of the gala was a live auction conducted by MC Mike Inouye. There were also three door prizes.



Heiwa... by Leon Kimura

Universal Peace Day commemorates the anniversary of the bombing of Hiroshima (August 5th in the USA and August 6th in Japan) with the goal of connecting people around the world to transform the remembrance of horror into a rededication of life. This year, on September 21st, the Community Arts and Lectures Program led by **Professor Merylee Shelton** at San Jose City College, held a United Nations Universal Day of Peace ceremony with multicultural folk singing, dancing, exhibits and festivities at the Carmen Castellano Fine Arts Plaza.

Included in the program was the dedication of the new Peace Pole in the plaza inscribed with the message: "May Peace Prevail on Earth" in various languages including Japanese. A short speech was given by **Dr. Sharat G. Lin** - President, San Jose Peace and Justice Center, and community representatives were present to read the peace pole inscriptions in the native tongue. Both **Fran Ellis** with the Nihonmachi Outreach Committee and myself were asked to "read" the Japanese inscription for the assembled crowd. Since neither of us read Japanese, our peace on earth translations were each a bit different but at least they both contained the word "Heiwa" (peace)! ;)




